## CCNJ APPOINTS BRIAN MONTAG FROM K&L GATES AND STEVEN UELAND FROM LANGAN TO ITS BOARD OF DIRECTORS, AND NAMES TWO NEW MEMBERS TO THE EXECUTIVE COMMITTEE

Since its founding, membership on the Chemistry Council of New Jersey's Board of Directors was limited to representatives from its Regular Member companies, which are identified as chemistry industry manufacturers. Associate Member companies are those companies that provide services to the business of chemistry, such as law firms and engineering and environmental firms.

"Associate Members makeup an increasing number of our overall membership base," said Chairwoman Leslie Waller, director of Chemistry, Energy and Environmental at Messer Americas. "When I was appointed chair of the Board, I wanted to make our organization representative of our changing industry and more inclusive of all of our member companies. Creating these two new Board roles for representatives from Associate Member companies does just that."
